PUBLIC RELATIONS GUIDELINES FOR PARKSMART CERTIFICATION

Congratulations! Your project is joining a select group of sustainable and innovative parking structures that are Parksmart-certified. The Parksmart rating system is owned and administered by Green Business Certification Inc. ([GBCI](#)) and distinguishes forward-thinking parking facilities shaping tomorrow's sustainable mobility network. If you are looking to tell your project's story, here are some ideas to get you started.

DISTRIBUTE A PRESS RELEASE

Once you've earned Parksmart certification, go ahead and make it known! A press release template, sample quotes from GBCI and other resources can be found in these guidelines. BRANDING GUIDELINES

GBCI NAME

The official organization name is Green Business Certification Inc.[™] and GBCI[®] is the official acronym. GBCI can be used after the first reference. Do not use articles like “the” or “a” when using GBCI as a noun or in the possessive.

TRADEMARKS

Follow all guidance detailed in the [GBCI Trademark Policy & Branding Guidelines](#), and contact GBCI's marketing department, marketing@gbci.org, with any questions about branding or use of the trademark and logo.

CERTIFICATION LEVELS

There are four levels of Parksmart certification – Pioneer, Bronze, Silver and Gold. When a project achieves certification it should be referred to as a Parksmart-certified project. If appropriate, supporting text may be written that gives additional detail about the specific rating system under which the project was certified.

- “Parksmart certification” with lowercase “c” is used to describe the certification process.
- “Parksmart-certified” with lowercase “c” is used to describe a project that has been certified.

When a project is certified, the correct wording is “project X is Parksmart Silver” or “project X is Parksmart certified to the Silver level” or “project X is Parksmart Silver certified.”
